MANNA EMPLOYS A "CHOICE" MODEL, SO THAT CLIENTS CAN SELECT THE ITEMS THEY WANT. THE AMOUNT OF FOOD THEY RECEIVE IS BASED UPON FAMILY SIZE, AND THERE ARE NO MAXIMUM INCOME EXCLUSIONS. ALL FOOD IS DONATED BY THE COMMUNITY; SCHOOLS, BUSINESSES, INDIVIDUALS, CIVIC ORGANIZATIONS DONATE PERISHABLE AND NONPERISHABLE FOOD. FRESH PRODUCE IS PROVIDED WEEKLY BY PHILABUNDANCE, AND OTHER FOOD IS MADE AVAILABLE THROUGH OUR COOPERATION WITH THE COMMUNITY NUTRITION COALITION, A CONSORTIUM OF LOCAL FOOD CUPBOARDS.
